Incorporation of Professionals: What's the latest?

At this time, four professional groups in Quebec can incorporate. Do you know which ones? They are chartered accounts, lawyers, notaries and certified general accountants.

Chartered accountants were the first to be able to practice their profession within a joint-stock company or a limited liability partnership (L.L.P.) as legislation was introduced in February 2003. Lawyers came after in May 2004 and finally notaries and certified general accountants followed suit in December 2005.

Company vs. L.L.P.

Given the new legal vehicles under which these professionals may practice their activities, why haven't we seen more professionals avail themselves of the company structure? Instead, several law firms, for instance, have chosen to continue to practice under limited liability partnerships. Is this due to the various regulatory requirements to practice within a company? Or is this simply a question of old habits dying hard for some of these traditional professions?

One plausible reason may be that the creation of a company may necessitate a specific legal and tax structure that may not adequately fit the needs of some of these professionals.

Comparative Chart

After being inspired by a conference held by APFF on the subject¹ and an article entitled "SENCRL OU SPA? faites un choix éclairé"², Ms. Annie Fredette of our CRAC team, summarized the information required in the articles of incorporation for a company of professionals. In the form of a chart, the different regulatory requirements were outlined for each of the four professions wishing to practice their professional activities within a company.

For example, the chart deals with the main conditions that must be set out in the articles of incorporation as well as the conditions regarding the corporate name of the company. A common denominator that seems to emerge from the regulatory requirements is that the control of the company must be held by the professional both on the board of directors and in the holding of the voting shares.
